ARTICLES OF ORGANIZATION

OF

AUCTION LADIES OF SOUTH FLORIDA LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **AUCTION LADIES OF SOUTH FLORIDA LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 15102 Southwest 25th Street, Davie, Florida 33326 and the mailing address shall be the same.

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 4 - DURATION

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE 7 - ADMISSION OF NEW MEMBERS

These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 


