Mr. Jones was not authorized to file such a report, and had no authority to do so as he was not a member nor a manager of Chase, and had not been since December 2018, as reflected in Exhibit A.
- 7. On October 20, 2020, I filed with the Florida Secretary of State an amended Annual Report to restore the correct management of Chase. A true and correct copy of said document is attached hereto as Exhibit E.
