AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
WINTER PARK PEDIATRIC DENTISTRY, LLC

The Articles of Organization of Winter Park Pediatric Dentistry, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on March 1, 2017, with an effective date of February 28, 2017. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is Winter Park Pediatric Dentistry, PLLC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address and the street address of the principal office of the Company is 3379 Lakeview Oaks Drive, Longwood, Florida 32779.

ARTICLE III - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Company is 3379 Lakeview Oaks Drive, Longwood, Florida 32779. The name of the registered agent of the Company at that address is Nicholas A. White.

ARTICLE IV - PURPOSE

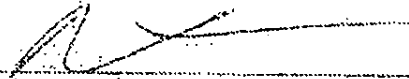

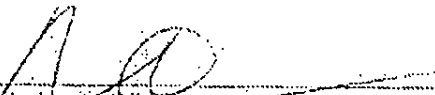
