ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
FKP TAMPA II, LLC

The undersigned, being a Manager of FKP TAMPA II, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is FKP Tampa II, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective March 1, 2017, and the Florida document number assigned to this Company is L17000047941.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.


5. These Articles of Amendment have been approved by unanimous Written Action of the Members dated as of March 8, 2018, which vote is sufficient for approval.
