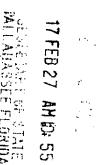

ARTICLES OF ORGANIZATION OF MONORSIDE LLC

ARTICLE XII - DISSOLUTION

This Company may be dissolved at any time on the affirmative vote of at least two thirds (2/3) of majority of the members of this Company entitled to vote thereon.
