ARTICLES OF ORGANIZATION

The undersigned person, acting hereby as Organizer for the purpose of forming a limited liability company under the Florida Statutes, Chapter 605, hereby executes the following Articles of Organization:

- I NAME. The name of the limited liability company shall be: All Care Urgent Care, LLC ("Company").
- II ADDRESS. The address of the principal office of the Company shall be 21750 S.R. 54, Lutz, Florida 33649. The mailing address of the Company will be 4355 Harbor Point Drive, Port Richey, FL 34668.
- III DURATION. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization
- IV REGISTERED OFFICE AND AGENT. The name of the registered agent of the Company in the State of Florida is Imad Jandali, and the street address of the registered office of the Company is 4355 Harbor Point Drive, Port Richey, FL 34668.
- V CAPITAL CONTRIBUTIONS. The members of the Company shall contribute to the capital of the Company in cash or property. Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.
- VI ADMISSION OF NEW MEMBERS. No additional members shall be admitted to the Company without the written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members.
