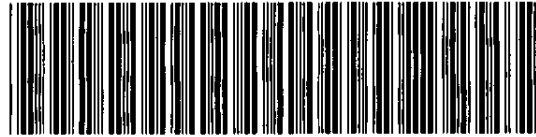

**ARTICLES OF ORGANIZATION
OF

The undersigned, MIKE GALVIN, as the subscriber to these Articles of Organization, hereby presents these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 605.

**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**

**ARTICLE II.
TERM OF EXISTENCE**

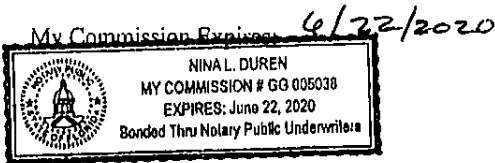
