**ARTICLES OF ORGANIZATION
FOR
WONDERWORKS HOLDINGS, LLC**

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of WONDERWORKS HOLDINGS, LLC under the Florida Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company (the "Company") is:
