ARTICLES OF ORGANIZATION OF TOPCOAT USA, LLC

The undersigned, for the purpose of forming a limited liability company for profit in the laws of Florida, adopts the following Articles of Organization:

Article I Name

The name of this limited liability company shall be TOPCOAT USA, LLC.
