**ARTICLES OF ORGANIZATION
OF
MCCORMICK MEDICAL, PT, AND BRACING, LLC**

The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

**ARTICLE I
NAME & ADDRESS**

The name of this limited liability company is MCCORMICK MEDICAL, PT, AND BRACING, LLC (the "Company"), and its principal office and mailing address is 11631 Bristol Chase Dr., Tampa, Florida 33626.

**ARTICLE II

ARTICLE IV
OPERATING AGREEMENT


