3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.


4. Place of Principal Office. The mailing and street address of the Company's principal office is 2600 Lucien Way, Suite 100, Maitland, Florida 32751.
