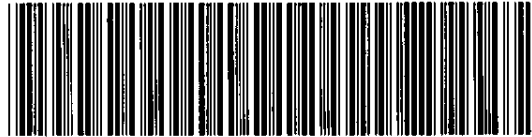

THIRD: The mailing address and street address of the principal office of the Limited Liability Company is 6455 Chatham View Court, Windermere, FL 34786.




