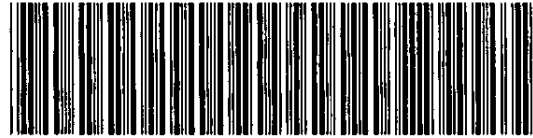

ARTICLES OF ORGANIZATION OF
FIELD FRESH FARMS, LLC

The undersigned, desiring to form a limited liability company under and pursuant to §605.0201, Florida Statutes, does hereby certify as follows:

ARTICLE I
NAME

The name of said limited liability company shall be:

Field Fresh Farms, LLC

ARTICLE II
TERM

Field Fresh Farms, LLC shall exist in perpetuity.

ARTICLE III
PRINCIPAL OFFICE



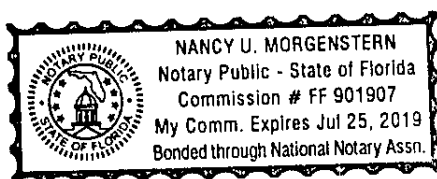
