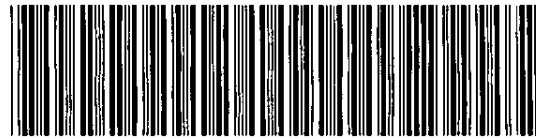

Principal Office**


