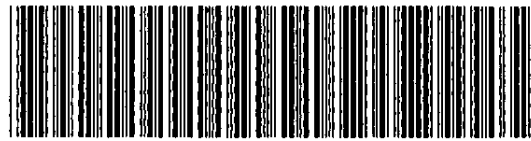

The name of this Limited Liability Company is **KEN DAVIS ENTERPRISES, L.L.C.**


