**ARTICLES OF ORGANIZATION
OF
MD CENTRAL FLORIDA, LLC**

1. Name. The name of this limited liability company is **MD CENTRAL FLORIDA, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of March 22, 2017 and shall thereafter be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 1511 N. West Shore Boulevard, Suite 750, Tampa, Florida 33607.

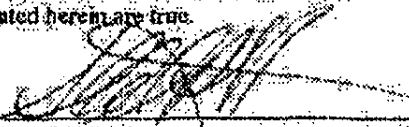

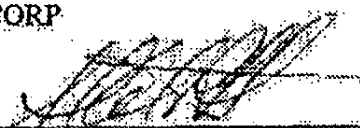
