# ARTICLES OF ORGANIZATION FOR RUTH REALTY HOLDINGS, L.L.C.

## **ARTICLE I - NAME**

The name of the Limited Liability Company is RUTH REALTY HOLDINGS, L.L.C.

#### ARTICLE II - ADDRESS

# **ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS**

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning one hundred percent (100%) of the outstanding Member Units of the Limited Liability Company.
