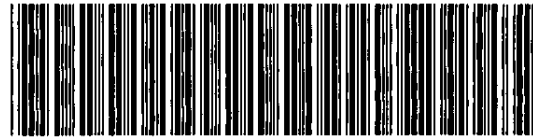



Pursuant to section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act"), it is hereby certified as follows:

**FIRST:** The names of the merging entities are SEO SITE CHECKUP LLC, a New York limited liability company (the "Terminating Entity"), and SEO SITE CHECKUP LLC, a Florida limited liability company (the "Surviving Entity").

**SECOND:** The merger herein certified was approved by the sole member of each of the Terminating Entity and the Surviving Entity and a Plan and Agreement of Merger for merging the Terminating Entity with and into the Surviving Entity, has been adopted, approved, certified, executed and acknowledged by the Surviving Entity in accordance with sections 605.1021 through 605.1026 of the Act, by the Terminating Entity in accordance with the laws of the State of New York, and by each member of the merging entities who as a result of the merger will have interest holder liability under section 605.1023(1)(b) of the Act.

**THIRD:** The Surviving Entity will continue its existence as the Surviving Entity under its present name pursuant to the provisions of the Act.

**FOURTH:** The Articles of Organization of the Surviving Entity shall remain the Articles of Organization of the merged entities.

**FIFTH:** The Surviving Entity agrees to pay any members with appraisal rights the amount, to which members are entitled under sections 605.1006 and 605.1061 through 605.1072 of the Act.


**SIXTH:** The effective date of the Articles of Merger shall be April 30, 2017.
