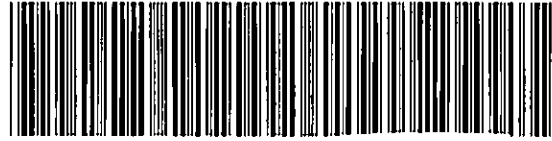

**ARTICLE I – INTRODUCTION AND PRELIMINARY STATEMENTS**

My Price Lawyers, LLC was formed as a limited liability company under the Laws of the State of Florida by delivery of Articles of Organization to the Department of State of the State of Florida, in accordance with Florida Revised Limited Liability Company Act on March 20, 2017. The members have agreed to amend and restate the Articles of Organization as provided herein.

**ARTICLE II -- NAME**

The name of the limited liability company is My Price Lawyers, LLC, a Florida limited liability company ("Company").

**ARTICLE III – PRINCIPAL OFFICE AND LOCATION OF RECORDS**

The mailing address of the Company is 211 S. Florida Ave., Lakeland, FL 33801. The street address of the principal office is 211 S. Florida Ave., Lakeland, FL 33801.

**ARTICLE IV -- DURATION**

The Company's existence shall be perpetual, starting on the original filing date of the Articles of Organization with the Department of State of the State of Florida, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE V -- PURPOSE**

The Company's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The Company has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

**ARTICLE VI -- REGISTERED AGENT AND OFFICE**

The name and street address of the registered agent of the Company in the State of Florida is Burnett, P.A., 211 S. Florida Ave., Lakeland, FL 33801.

**ARTICLE VII -- REGISTERED AGENT CONSENT**

I, Douglas K. Burnett, as President and on behalf of Burnett, P.A., a Florida professional association, accept the appointment as Registered Agent of My Price Lawyers, LLC, a Florida limited liability company. ARTICLE VIII -- CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the Company the cash or property as set forth in the Amended Operating Agreement of My Price Lawyers, LLC dated ("Operating Agreement").

ARTICLE IX -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only on the unanimous consent of all the members, as provided in the Operating Agreement.

ARTICLE X -- ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE XI -- TERMINATION OF EXISTENCE

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

ARTICLE XII -- MANAGEMENT

The Company shall be managed by managers in accordance with the Operating

Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 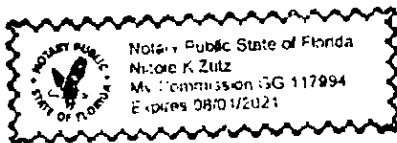
