**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **HEALTH MARKETERS OF CENTRAL FLORIDA, LLC**, a Florida limited liability company (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 1608 21<sup>st</sup> Street North, Jacksonville, FL 32250.




