**ARTICLES OF ORGANIZATION
OF
GoVi ADVENTURES LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is GoVi Adventures LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address of the Company shall be 401 East Las Olas Boulevard, P.O. Box #130646, Ft. Lauderdale, FL 33301. The street address of the principal office of the Company shall be 600 West Las Olas Boulevard, Unit 1503, Ft. Lauderdale, FL 33312.

ARTICLE III. REGISTERED AGENT AND OFFICE


ARTICLE IV. DURATION


