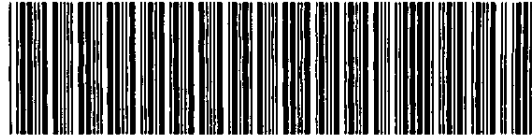

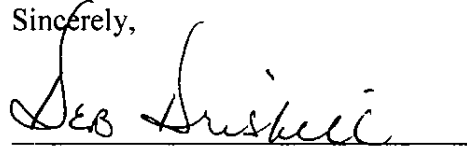

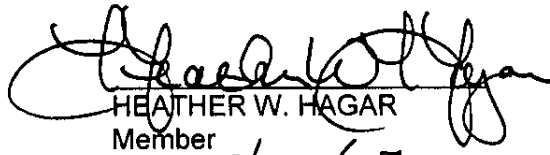
ARTICLE III – MANAGEMENT

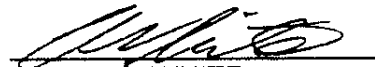
