The undersigned, Scott Barnes, a natural person competent to contract and a member of Scott Barnes, LLC, hereby presents these Articles of Organization as the Articles of Organization of Scott Barnes, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**


