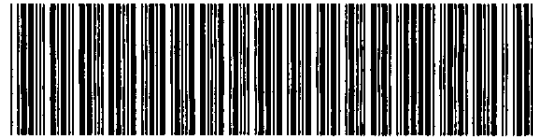

The name of the limited liability company shall be **TNT STEPS TRAINING, LLC.**

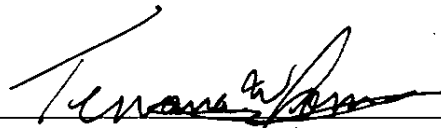
ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND ADDRESS

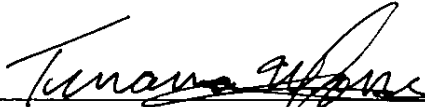
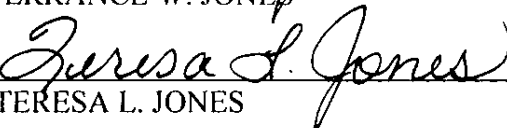
ARTICLE VII - CONTINUATION OF BUSINESS
