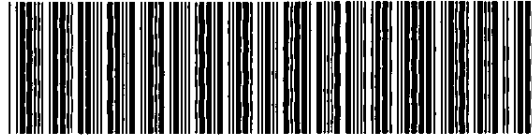

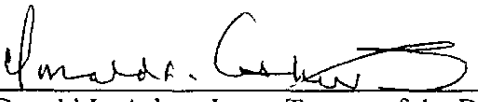

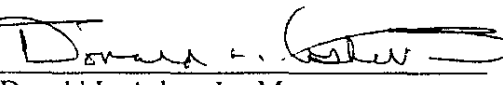
1. The name of the Florida Limited Liability Partnership converting into the Limited Liability Company is: MJ BUILDING, LLP.

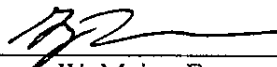
