ARTICLE I – Name

The name of the Limited Liability Company is EQUINE ATHLETE THERAPY, LLC (the "Company").

ARTICLE II – Address

The Company shall commence its existence as filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless the Managing Members of the Company approve of the proposed transfer by unanimous written consent. 
ARTICLE IX - Management




