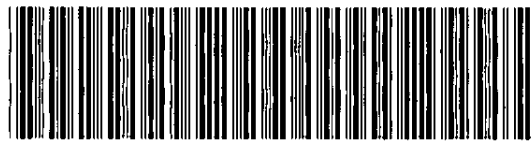

THIRD: The mailing address and street address of the principal office of the Limited Liability Company is 1053 Soaring Eagle Lane, Kissimmee, FL 34746.






