The undersigned, for the purpose of forming a limited liability company and the Florida Limited Liability Company Act, Florida Statutes Chapter 605 hereby makes, acknowledges, and files the following Articles of Organization.

# **ARTICLE 1 - NAME**

The name of the limited liability company shall be MARTIN SONS TRANSPORT LLC ("Company").

#### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 105 Northeast 342nd Trail, Okeechobee, Florida 34972 and the mailing address shall be the same.

### **ARTICLE 3 - EFFECTIVE DATE**

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

#### **ARTICLE 4 - DURATION**
