### ARTICLE 1 - NAME

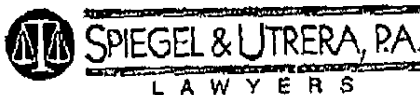
**ARTICLE 9 - MANAGEMENT**




