#### ARTICLES OF ORGANIZATION

OF

#### WHISTLING PINES RANCH, LLC

AGREEMENT made as of the 3 day of hori, 2017, by NANCY W. McCULLOUGH and DAVID R. WILLIAMS, (hereinafter the Members);

NOW THEREFORE, it is mutually agreed as follows:

#### **ARTICLE I**

#### FORMATION OF LIMITED LIABILITY COMPANY
