AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF GLOBAL MARINE BROKERAGE, LLC
(a Florida Limited Liability Company)

The address of the registered office of the Company is 2600 McCormick Drive, #200, Clearwater, Florida 33759.


ARTICLE V - MANAGEMENT


