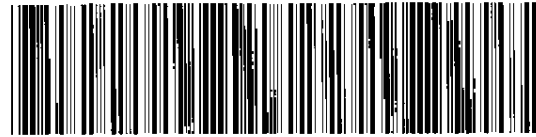

**ARTICLES OF ORGANIZATION
OF
AD COVERAGE COMPANY LLC**

The undersigned, for the purpose of forming a Limited Liability Company under the "Florida Revised Limited Liability Company Act," F.S. Chapter 605 (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I

The name of the limited liability company is **AD Coverage Company LLC** (the "Company").

ARTICLE II

The principal place of business and mailing address of the Company shall be 8730 NW 36th Avenue, Miami, Florida 33147.

ARTICLE III

The Company may transact any and all lawful business for which limited liability companies may be organized under the Florida Revised Limited Liability Company Act.

ARTICLE IV

In accordance with Section 605.0108(3) of the Act, the term of existence of the Company shall commence upon filing these articles of organization with the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved.


