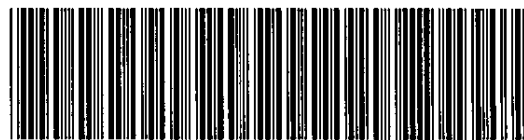

1. ARTICLES OF ORGANIZATION (PURSUANT TO CHAPTER 605, Fla. Stats.).

**ARTICLE I  
NAME**
