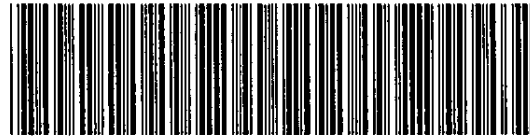

**ARTICLE I
NAME**

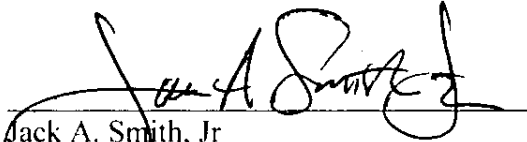
ARTICLE VI PROPERTY

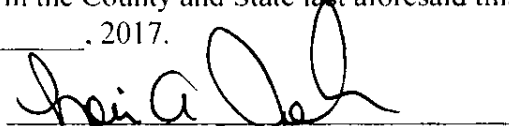

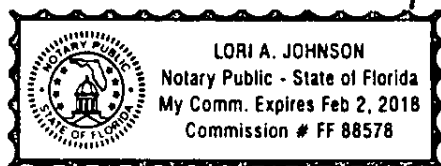
