**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
PERSONALIZED ORTHOPEDICS OF THE PALM BEACHES PLLC**

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, PERSONALIZED ORTHOPEDICS OF THE PALM BEACHES PLLC, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:
