Article IV of the Articles of Organization of Sonco Land, LLC is hereby amended, Article IV or read as follows: in its entirety, to read as follows:

"Article IV

Management by Manager(s). This shall be a manager-managed Company. and shall not be managed by its members. As such, the management and control of the business and affairs of the Company shall be vested in one or more Manager(s) in accordance with these Articles of Organization, F.S. Section 605.0407 of the Florida Revised Limited Liability Company Act (the "Act"), and the Operating Agreement adopted by this Company.

The Manager(s) shall be designated, appointed, elected, removed, or replaced in accordance with the terms of the Operating Agreement and Florida law. A Manager must be a natural person who is eighteen (18) years of age or older, must be a resident of Florida, and need not be a Member of this Company.

The number of Manager(s) constituting the initial management of this Company shall be one (1). The number of Managers shall be fixed by the Operating Agreement of this Company and may be changed from time to time, but shall never be less than one (1). The name and address of each person who is to serve as an initial Manager of this Company is/are as follows:

In the event of any conflict between the terms and provisions of the Act and these Articles of Organization, these Articles of Organization shall govern and control except to the extent such term or provision is prohibited, or deemed invalid, by the Act.

Unless otherwise required by Florida law, a majority of the Manager(s) shall constitute a quorum of the Manager(s) for the transaction of business. The affirmative vote of a majority of the Manager(s) present at a meeting at which a quorum is present is required to constitute any act or decision of the Manager(s)."
