

To whom it may concern,

Please find attached the forms for New Filing Section, Division of Corporations for the State for Florida. I am the owner of Livin' Clean, LLC and moved to the North Port area in August 2016. My company is registered in Michigan with its own FEIN number so when I moved to Florida I registered it as a foreign entity in order to avoid having to create a new FEIN number.

During the middle of February I was forced to sell my clientele list for my Michigan operation due to insubordination with employee staff. I did not sell the company, only the clientele, so Livin' Clean, LLC is no longer operating in the State of Michigan. I paid my fees on March 29, 2017 through Sunbiz.org for the 2017 year for Livin' Clean, LLC as a foreign entity. I called this week to see what it would take to convert my very small company from a foreign entity to a Florida company. I was informed that I would have to pay another \$150.00 to do this.

I completely understand that fees need to be paid to become legal operating businesses in the State of Florida, but was truly hoping that the State of Florida could refund the fess I have already submitted last week and apply to this new filing. There did not appear to be any willingness to work with me on this request with the two different customer service reps I spoke with on the phone.

I have enclosed a check for \$150.00, but if you feel compelled in any way to issue a refund for the difference between this fee and the \$139.00 I paid just last week, you would definitely make this small business owner very happy.

Thank you in advance for your time and consideration with this matter.
