OF
REALIZE COUNSEL PLLC
(A Florida Professional Limited Liability Company)

ARTICLE I
NAME

The name of the professional limited liability company is Realize Counsel PLLC (the "Company").

ARTICLE II
ADDRESS OF PRINCIPAL OFFICE

ARTICLE III

The effective date of the Company's Articles of Organization is April 12, 2017.

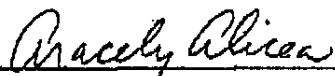
ARTICLE VII
