The street address and mailing address of the principal office of the Company is 3350 SW 148<sup>th</sup> Avenue, #110, Miramar, Florida 33027.

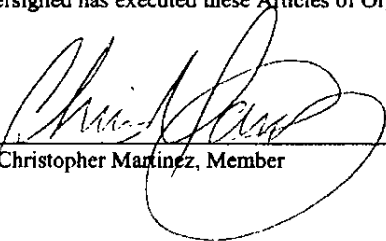

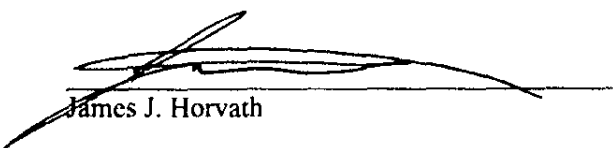
