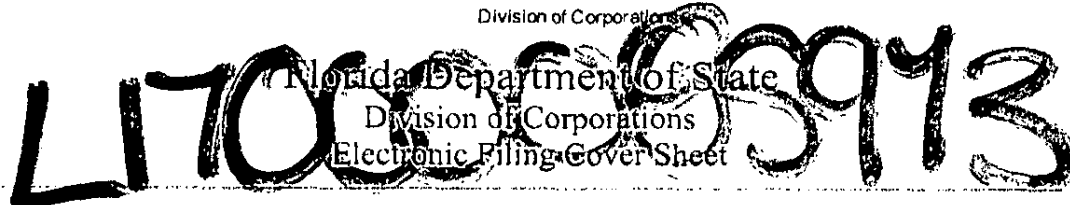

**ARTICLES OF AMENDMENT
TO THE

2. **Article V.** is hereby added to the Articles of Organization. **Article V.** immediately following **Article IV.**, and shall read as follows:

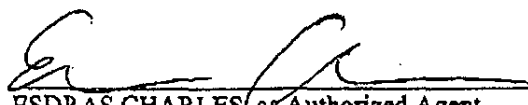
