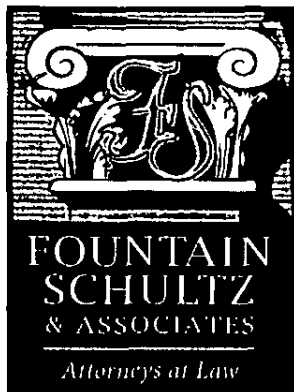


ARTICLE IX - MANAGEMENT


