**ARTICLE I**

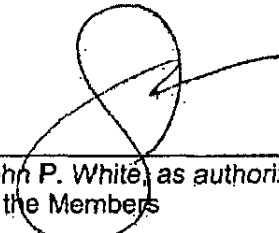
The following amendment to change the name of the Company was approved and adopted in accordance with Chapter 605, Florida Statutes:
