The mailing address and street address of the principal office of the Company shall be c/o 808 Ponce de Leon, Coral Gables, Florida, 33134.

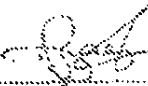

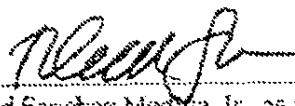
