Management of Business

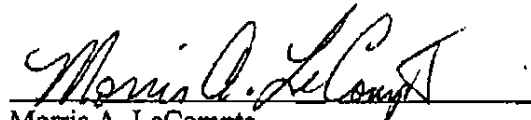
