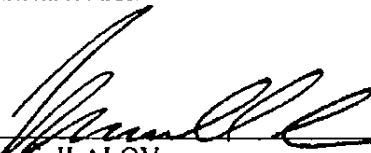

ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is KFI HOLDINGS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
2. Duration. The Company's existence shall be effective as of April 27, 2017 and shall thereafter be perpetual.

The undersigned executed these Articles of Organization on the 27 day of April, 2017.

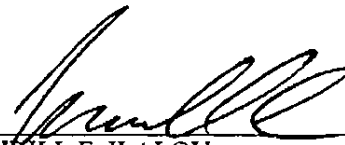
