**ARTICLES OF ORGANIZATION
OF
RMF CAPITAL HOLDINGS, LLC**

1. Name. The name of this limited liability company is RMF CAPITAL HOLDINGS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be perpetual.


