ARTICLE 1 - NAME

ARTICLE 9 - MANAGEMENT

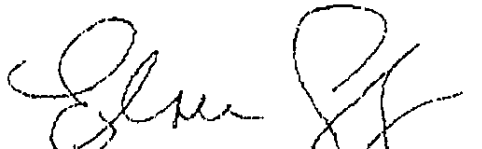

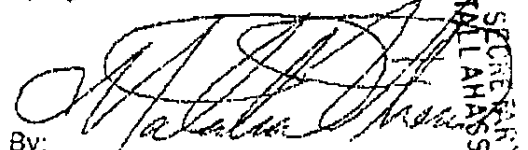
