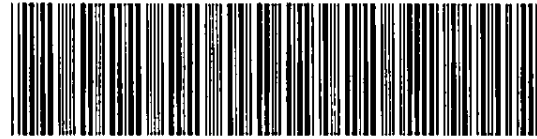

TO THE
ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of § 605.0202 of the Florida Revised Limited Liability Company Act (the "LLC Act"), PRO OPZ - PROPZ, LLC, a limited liability company organized under the provisions of the LLC Act (the "Company"), hereby adopts the following Articles of Amendment to its Articles of Organization as of this fifth day of September 2017:

- (1) The present name of the Company is PRO OPZ - PROPZ, LLC.
- (2) The date of filing of the Company's Articles of Organization was May 1, 2017.
- (3) The text of the amendment to the Articles of Organization is as follows:

Article I of the Articles of Organization is hereby amended to change the name of the Company from "PRO OPZ - PROPZ, LLC" to "PROPZ, LLC."

Article IV of the Articles of Organization is hereby amended to remove Thomas Affatato as the manager of the Company and to replace him with Deborah Affatato.
