**ARTICLE III. PURPOSE**


The purpose for which the Limited Liability Company is organized is any and all lawful business that may be authorized pursuant to the Act.

**ARTICLE V. DURATION AND COMMENCEMENT DATE**


The Limited Liability Company shall have perpetual existence commencing on May 2, 2017.
