**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, *F. S. Ch. 605*, hereby make, acknowledge, and file the following Articles of Organization:

ARTICLE I

The name of the limited liability company shall be **MENZE PRECISION MACHINING, LLC** (the "Company").

ARTICLE II

The mailing address and the street address of the Company shall be **48 Stephenson Ave., Babson Park, FL 33827**.

ARTICLE III

The Company shall be a Member Managed Company by one or more Members in accordance with the Operating Agreement adopted by its members for the management of the business and affairs of the Company, which regulations may contain any provision for the regulation and management of the affairs of the Company not inconsistent with Florida law or these Articles of Organization.

By execution of these Articles of Organization and pursuant to F.S. §605.0113, the undersigned, **ROBERT CHASE MENZE**, is designated as and hereby accepts the appointment as registered agent simultaneously with being so designated, and further the undersigned is familiar with, and accepts, the obligations of that position as provided in F.S. Ch. 605.

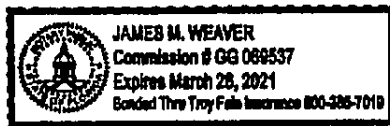
